 - \circ $\;$ Increased membership growth and initiatives as well as IVECCS growth
- VECCS Financial audit
 - Full audit performed in 2022, Accountant review in 2023, no concerns flagged
- Support of Asian colleagues JaVECCS
 - JaVECCS meeting, BOD approved financial support of \$75,000 for JaVECCS over 5 years. Chris Gray, Steve Epstein, and Ken Yagi attended 1st JaVECCS international conference, which was very successful and exceeded expectations

 - BOD approved purchase of a building in San Antonio

- Power of Ten
 - o 2nd Leadership cohort graduated this week

- Membership
 - End of August 2024 7128 members
- IVECCS 2024
 - o 2024 IVECCS not as well attended as Aurora, CO 2023
 - CO destination venue and also directly after COVID
- 2024 IVECCS
 - 4990 registrations by end of August, now over 5000 registrations total, on site 4200 persons, 3100 attendees after subtraction of guests and exhibitors
- Virtual attendees has decreased this year (15% virtual versus 20% in 2022)
- Exhibitors highest number of exhibitors ever 312 booths and 60 exhibitors at Career Fair

1:32 pm CST VECCS Financial Update – Ridglea Callahan Director of Finance

- Increase in assets in 2023 from 2022 due to success of IVECCS 2023
- Increase liabilities 2023
 - \circ $\,$ Loan for office completion, paid off in full in 2024 $\,$
- Profit and Loss statement
 - Operational costs have increased
- Graphical numbers from 2022 and 2023 projected against budget
 - In September VECCS recognizes all of income from IVECCS and expenses and is on same trajectory as usual
- 2024 Highlights
 - Competed construction of office, moved in March 1
 - o Negril, Jamaica in March
 - o Grand Opening and Ribbon cutting in April 2024
 - o 3 additional staff members to serve the growing membership and society
- Future BOD meetings, IVECCS Planning meetings, labs and other events are planned for last quarter of 2024 in our new VECCS office

1:36 ACVECC and VECCS Joint Educational Initiatives - Nicolette Zarday

- Dr. Zarday entered role as Director of Certificate programs along with Dr. Elise Boller, as program developed jointly with ACVECC
- 3 levels for ER Veterinarians
 - Foundations in Veterinary Emergency and Critical Care (FVECC)
 - All e learning and self-paced
 - Covers broad array of ER topics

- Early Career/Intermediate Level
 - Program accreditation- program for employer-delivered training programs, this is not a direct training program for veterinarians
 - Advanced Emergency Veterinarian Certificate Program
 - Is currently in design
 - 2 year cohort-based program for experienced veterinarians
 - Is not yet prepared for launch date
- Developed a Competency Framework with 3 proficiency/milestone levels
- Foundations has launched
 - 40 modules of on line e learning each ~ 1 hour to complete
 - Target audience students recent grads, new ER doctors, or doctors that want to refresh or update knowledge as well as persons to ER or people who see ER cases in general practice
 - Learning.acvecc.org
 - More than 50% of modules are completed, with the remainder to be released in the next 4 months
 - All are available for RACE credit for professionals
- Intermediate Program
 - o Accreditation program for employer delivered programs
 - Meet standards of ACVECC and VECCS
 - Aligns with the competency framework on the milestone level
 - Focus to raise awareness and visibility of high-quality early ER Veterinary programs
 - \circ Plan to launch in ~ 6 months
- Advanced Program
 - Is least far along in development
 - Purpose to give experienced ER vets opportunities for professional development and work synergistically with Diplomates
 - 2 year program with 1 month long units
 - Geared for people to do while they work in emergency and so is reinforced with clinical work
- There is no final summative exam but will be assessments along the way
 - Assessment incorporates previous learning
 - Delivery of psychomotor skills is important
- Not ready yet to publish timeline for enrollment and launch
- Aligned to Advanced milestone of competency framework
- Dr. Zarday thanked the many members of VECCS and ACVECC and others who have supported this endeavor
 - Question: Would there be a potential for collaboration of the middle certificate with AAHA who certifies Emergency Facilities?
 - Answer: AAHA provides a good example on how to do facility certification, however we are looking at VECCS Facilities certification as the leaders as to how to accreditation

- Dr. Karl Jandrey discussed that at the ACVECC Business meeting, advertising to the 10-12 developing veterinary schools in the next 5-10 years, who may not be able to staff faculty
 - Recommends marketing to AAVMC and leaders; partnering with vet schools is a good consideration
 - AAVMC meeting is in early April 2025 Dr. Jandrey to help bring information to that meeting

- Increase leadership presence in VECCS leadership
- In survey July 2024, 55% of response identified as leaders or managers within a practice (majority of our members identify as leaders in their practice)
